

Khula & NADRA Divorce Certificate with MOFA Attestation Case Study (Overseas Pakistani – United Kingdom)

Title

Husband Gives Verbal Divorce Without Documentation – Khula, NADRA Divorce Certificate & MOFA Attestation Delivered to UK via DHL

Background

A **Pakistani female** client residing in the **United Kingdom** contacted our legal team after her husband had pronounced **verbal divorce** (talaq) three times. However, no written documentation or legal process was completed, leaving her marital status unclear for legal and immigration purposes.

Problem

- Husband had given verbal divorce but refused to provide written confirmation
- No official record of divorce existed in Pakistan
- The client was residing abroad and unable to appear in court
- She required a legally recognized divorce status along with attested documents for use in the United Kingdom

Legal Action Taken

To regularize her legal status, our legal team initiated a **Suit for Dissolution of Marriage on the Basis of Khula** under **Section 10(4) of the West Pakistan Family Courts Act, 1964**, read with **Section 8 of the Muslim Family Laws Ordinance, 1961**, through a Special Power of Attorney (SPA) executed by the client in the United Kingdom.

 - Drafting and attestation of Special Power of Attorney
 - Filing the case in Family Court Lahore
 - Full legal representation on behalf of the client
 - Arrangement of video call statement (bayan) with court permission
 - Generation of Court-Attested Khula Decree

- Submission of file in NADRA Union Council for NADRA Divorce Registration Certificate
- Generation of NADRA Divorce Certificate
- Attestation from Ministry of Foreign Affairs (MOFA), Pakistan, on client request
- Regular updates and consultation with the client before and after every step

Challenges Faced

- No written proof of divorce from husband
- Husband's non-cooperative behavior
- Overseas documentation and attestation requirements
- Coordination of remote court appearance via video link

Result

- Khula decree granted by Family Court Lahore
- Marriage legally dissolved and status regularized
- NADRA Divorce Registration Certificate successfully issued
- Divorce documents attested by Ministry of Foreign Affairs (MOFA), Pakistan
- Documents prepared with verification and bar code authentication

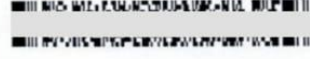

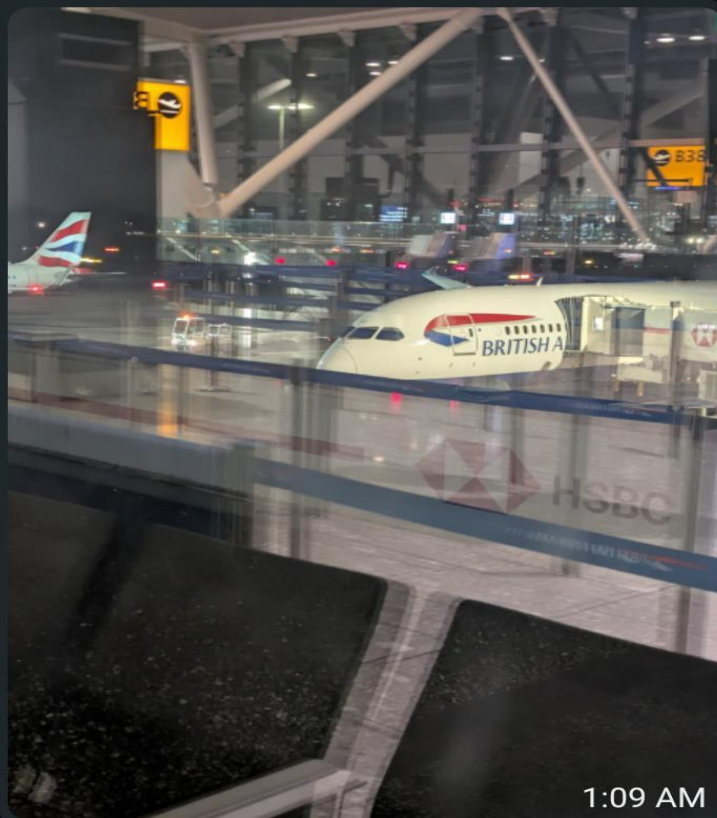
