### **Title**

No Marriage Certificate (also known as Single Status / Unmarried Certificate) with MOFA Attestation Delivered for Overseas Client from China – Completed Within 5 Working Days

---

### **Background**

A client residing in China contacted our legal team for the issuance of a **No Marriage Certificate (also known as Single Status Certificate / Unmarried Certificate)** from Pakistan, along with **Ministry of Foreign Affairs (MOFA) attestation** for official use.

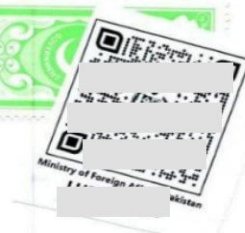
