### Title

**Online Khula Case for Pakistan-Based Client – Lahore Family Court Decree & NADRA Divorce Certificate with Remote Handling**

### Background

A female client residing in Pakistan contacted our legal team seeking **Khula (dissolution of marriage)** as her husband refused to grant divorce.

She required complete legal assistance for obtaining a **Khula decree from Lahore Family Court** along with a **NADRA Divorce Registration Certificate**, without personally attending court due to her job in Karachi.

### Problem

- Husband unwilling to give divorce
  - Client based in Karachi, case to be filed in Lahore
  - Unable to attend court hearings due to job commitments
  - Required complete legal solution including NADRA divorce certificate
  - Needed fast and smooth process without delays

## Legal Action Taken

## Legal Insight

A woman in Pakistan can seek Khula or dissolution of marriage under the following legal provisions:

### **Section 8 of the Muslim Family Laws Ordinance, 1961**

Allows dissolution of marriage through Khula where reconciliation is not possible.


### **Section 10(4) of the West Pakistan Family Courts Act, 1964**


Empowers the Family Court to pass a decree of Khula if reconciliation efforts fail.

### **Dissolution of Muslim Marriages Act, 1939 (Section 2)**

Provides additional grounds for dissolution of marriage, including:

- Cruelty
- Non-maintenance
- Desertion
- Failure of marital obligations

 In practice, courts grant Khula when the wife states that she cannot live with her husband within the limits prescribed by Islam, even without proving fault.

 Remote legal representation through a **Special Power of Attorney** allows clients to complete the entire process without appearing in court.

## Frequently Asked Questions (FAQs)

### 1. Can Khula be obtained without husband's consent?

Yes, the court can grant Khula even if the husband refuses.

### 2. Is personal court appearance necessary?

 No — the case can be handled through an attorney.

### 3. How long does Khula take?

Usually within 1–2 months depending on case circumstances.

### 4. Will I get a NADRA Divorce Certificate?

Yes, after decree and iddat period completion.

### 5. Can the entire process be done remotely?

 Yes, with proper legal authorization.

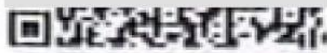
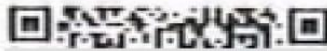
