## Background

## Problem

- After Eid, process initiated on **11th June 2025**
- Legal registration completed efficiently

## Step 3: NADRA Marriage Certificate

- **NADRA Computerized Marriage Certificate issued on 14th June 2025**
- Soft copy shared **instantly with the client**

## Step 4: Courier Delivery

- Upon receiving address details, documents were dispatched on **21st June 2025** as per client's request
- Delivered securely to bride in Pakistan
